43-1 The Meeting was called to order.

# 43-2 Construction Update:

The installation of the exterior hardscape, which includes the sidewalks, bollards, planters and fencing are all ongoing. The elevator installation is completed. The detention area is readying for preliminary inspection. The doors, hardware, millwork, whiteboards, acoustical panels, and carpet installation are all wrapping up. Tile in the main lobby has started. Security installation is ongoing. Start ups and testing have also started. Furniture delivery and assembly to start on July 17 and expected to take about three weeks.

### 43-3 Fitness Center

A formal proposal for the fitness center was distributed to the committee prior to the meeting. The Chief spoke briefly about the importance of the fitness center not only for the physical health but also the mental well being of the officers. The Chief searched but there are no available grants for police fitness centers. The fitness center would be located in half of the "future expansion" space. All the equipment pricing is from the state bid list. Jim Whitney asked if cost saving were possible by purchasing used equipment. Used equipment offers only a minimal cost savings when maintenance is considered into the costs. Additionally, gym memberships were suggested as a cost savings. However, the officers pointed out they are not comfortable in a public gym setting potentially next to folks they may have encountered during their work day.

There was a MOTION to approve the Fitness Center Equipment Proposal for \$77,110.21made by Kelley Gammell and SECONDED by Chief Kennedy.
